- Insurance: All Chalet Renters must have in effect, liability insurance of no less than \$250,000. This is required by Martin County as a condition of use of the airport. Chalet Renter will provide the Visiting Nurse Association Air Show, Inc. (VNAA) a "Certificate of Insurance" naming VNAA & Martin County as a certificate holder.
- Chalet Renter acknowledges that the Visiting Nurse Association Air Show, Inc. nor its officers, agents, employees or representatives, shall be liable or responsible for any injury to the undersigned, their employees, guests or invitees for any injury, damage or loss that may occur during the air show or while Chalet Renter is in transit to or from the air show.
- Chalet Renter shall comply with any and all applicable state, local or municipal regulations, laws and ordinances, included but not limited to health, fire, electrical and revenue. Chalet Renter shall collect and remit all sales tax, if required by Florida law.
- The Visiting Nurse Association Air Show, Inc. nor its officers, agents, employees or representatives, shall be liable or responsible for any event beyond its reasonable control such as acts of God, weather delays or government restrictions.
- This agreement shall not be in force until it has been signed below by the Chalet Renter or his duly authorized representative. The Chalet Renter or his representative is bound by and agrees to abide by the rules and regulations of this contract.
